This is in connection with the forthcoming Career Service (Sub-Professional and Professional levels) Examination to be held on August 3, 1986 in which Ormoc City has not been mentioned as one of the testing centers for this examination. In this regard, the undersigned would like to suggest that a resolution be passed to ask President Corazon C. Aquino that Ormoc City be considered one of the testing centers- as this place is a strategic one- geographical wise- for those examinees coming from the northern part to the southern part of this side of the island province of Leyte; essentially benefiting the constituents of Ormoc City. It may be mentioned that there were precedences to this kind of action of the then Municipal Board of Ormoc City in which the higher authority granted the request of the city officials.
