RESOLUTION NO. 100

A RESOLUTION AUTHORIZING THE HONORABLE OIC-CITY MAYOR EMETERIO V. LARRAZABAL TO ACCEPT THE DONATION OF 12 UNITS LIGHTING FIXTURES, 20-WATT, 220 VOLTS, COMPLETE WITH ACCESSORIES, TO BE INSTALLED AT STRATEGIC PLACES IN BARANGAY LINAO, THIS CITY, SUBJECT TO RESOLUTION NO. 1149 DATED APRIL 20, 1982.

"WHEREAS, this august body is in receipt of Unnumbered Resolution-Ordinance of the Sangguniang Panbarangay of Linao, appropriating the amount of Three Thousand Pesos (P3,000.00) from out of their 10% Realty Tax Shares for the purchase of 12 units fluorescent street lighting fixtures, complete with weather protector, mounting brackets, lead out electrical wires, 20-watt, 220 volts to be installed at the entry road of Purok 7 and at strategic areas around Barangay Linao, and donating the same to the city government of Ormoc for payment of power consumption;

"NOW, THEREFORE, on motion of Kagawad Hermosilla, seconded by Kagawad Yrastorza; be it

"RESOLVED, to authorize the Honorable OIC-City Mayor Emeterio V. Larrazabal to accept the donation of 12 units lighting fixtures complete with accessories, to be installed at strategic places in Barangay Linao, this city, subject to Resolution No. 1149 dated April 20, 1982;


