RESOLUTION NO. 103

A RESOLUTION EARNESTLY REQUESTING THE CITY ENGINEER TO CAUSE THE  
REPAIR OF THE BARANGAY ROAD, LEADING TO BARANGAY HIBUNAON FROM  
BARANGAY CABULIHAN.

"WHEREAS, this august body is in receipt of Resolution No. 4, Series  
of 1986 of the Sangguniang Pambarangay of Hibunaon earnestly requesting  
the City Engineer through the Honorable OIC-City Mayor, to cause the  
repair of the barangay road leading to Barangay Hibunaon from Barangay  
Cabulihan;

"WHEREAS, said resolution states that the 2 kilometers barangay road  
from Barangay Cabulihan is already dilapidated because of the recent  
typhoon that occurred this year and considering also that the last  
maintenance of the road was yet in 1984, so that the barangay residents  
find it very difficult and inconvenient to transport their products to  
the market;

"NOW, THEREFORE, on motion of Kagawad Subingsubing, seconded by  
Kagawad Hermosilla; be it


"RESOLVED, to earnestly request the City Engineer to cause the  
repair of the barangay road leading to Barangay Hibunaon from Barangay  
Cabulihan;

"RESOLVED, FURTHER, to furnish a copy of this resolution each to the  
City Engineer, and the Sangguniang Pambarangay of Hibunaon, through its  
Punong Barangay, both in Ormoc City;


