RESOLUTION NO. 104

A RESOLUTION AUTHORIZING THE CITY TREASURER TO RELEASE THE SUM OF FIVE HUNDRED PESOS (P500.00) FROM OUT OF THE BARANGAY DEVELOPMENT FUND TO BE MADE AVAILABLE FOR BURIAL BENEFITS TO THE SURVIVING HEIRS OF THE LATE KALIHIM SANTIAGO S. JIMENEA OF BARANGAY 29, WHO DIED ON OCTOBER 24, 1986, AS MANDATED IN SEC. 94, PARAGRAPH (3) OF THE LOCAL GOVERNMENT CODE.

"WHEREAS, the Sangguniang Pambarangay of Barangay 29, in its Resolution No. 1, series of 1986 has entreated this august Body to appropriate the amount of Five Hundred Pesos (P500.00) for burial benefits to the surviving spouse and legal heirs of the Late Kalihim Santiago S. Jimenea of Barangay 29, who died on October 24, 1986;

"WHEREAS, this august Body finds the request legal considering that it is mandated in Section 94, Paragraph (3) of the Local Government Code;

"NOW, THEREFORE, on motion of Kagawad Hermosilla, jointly seconded by Kagawads Yrastorza and Fiel; be it


"RESOLVED, to authorize the City Treasurer to release the sum of Five Hundred Pesos (P500.00) from out of the Barangay Development Fund to be made available for burial benefits to the surviving heirs of the Late Kalihim Santiago S. Jimenea of Barangay 29, who died on October 24, 1986, as mandated in Sec. 94, Paragraph (3) of the Local Government Code.

"RESOLVED, FURTHER, to furnish a copy of this resolution each to the City Treasurer, the City Budget Officer, and the Sangguniang Pambarangay of Barangay 29, all in Ormoc City;


