"WHEREAS, Kagawad Hermosilla manifested that the barangay residents of Hugpa have complained about the disappearance of the 500 lengths water pipes which have been allocated to them for their water supply project;

residents are now looking for these water pipes so the long felt-need water supply project may soon be realized;

is imperative to create a committee for a fact-WHEREAS, inding inquiry into the whereabouts of the 500 lengths water pipes in der to establish facts in aid of proper legislation;
