RESOLUTION NO. 106

A RESOLUTION CREATING A COMMITTEE TO BE HEADED BY HONORABLE ANTERO T. FIEL, KAGAWAD-IN-CHARGE, BARANGAY HUGPA, WITH AUTHORITY TO CHOOSE HIS MEMBERS, FOR A FACT-FINDING INQUIRY INTO THE WHEREABOUTS OF THE 500 LENGTHS WATER PIPES OF ASSORTED SIZES PROPERTY OF BARANGAY HUGPA.

"WHEREAS, Kagawad Hermosilla manifested that the barangay residents of Hugpa have complained about the disappearance of the 500 lengths water pipes which have been allocated to them for their water supply project;

"WHEREAS, the residents are now looking for these water pipes so that their long felt-need water supply project may soon be realized;

"WHEREAS, it is imperative to create a committee for a fact-finding inquiry into the whereabouts of the 500 lengths water pipes in order to establish facts in aid of proper legislation;

"NOW, THEREFORE, on motion of Kagawad Hermosilla, seconded by Kagawad Yrastorza; be it

"RESOLVED, to create a committee to be headed by Honorable Antero T. Fiel, Kagawad-In-Charge, Barangay Hugpa, with authority to choose his Members, for a fact-finding inquiry into the whereabouts of the 500 lengths water pipes which had been allocated to said barangay for their water supply project;
