RESOLUTION NO. 107

A RESOLUTION TO CREATE A COMMITTEE TO BE HEADED BY THE HONORABLE VICE-MAYOR, WITH AUTHORITY TO CHOOSE HIS MEMBERS TO INQUIRE INTO THE STATUS OF THE BIDA FUNDS OF P5,000.00 EACH PER BARANGAY ALLOCATED BY THE MINISTRY OF LOCAL GOVERNMENT WAY BACK IN 1979 OR THEREABOUTS OF WHICH SOME BARANGAYS WERE NOT ABLE TO AVAIL DUE TO TIME CONSTRAINTS.

"WHEREAS, all barangays in Ormoc City were recipients of the P5,000.00 each of the Barangay Improvement and Development Assistance (BIDA) Funds in term of checks from the Ministry of Local Government way back in 1979 or thereabouts;

"WHEREAS, some urban barangays were not able to avail of the funds due to the time constraints for delivery of materials;

"WHEREAS, Mr. Eufrocino Codilla, who won the bidding deposited some checks with the Philippine National Bank, to prevent the checks from being stale, but delivery has not been made to certain urban barangays;

"WHEREAS, it behooves to create a committee to enable the city government of Ormoc to ascertain the status of the P5,000.00 BIDA Funds released by the Ministry of Local Government in 1979 or thereabouts and had been allocated each to all barangays of Ormoc City, some of which have not yet availed of their funds;

"NOW, THEREFORE, on motion of Kagawad Hermosilla, seconded by Kagawad Yrastorza; be it

"RESOLVED, to create a committee to be headed by the Honorable

Vice-Mayor, with authority to choose his Members, to inquire into the status of the BIDA Funds of P5,000.00 each per barangay allocated by the Ministry of Local Government way back in 1979 or thereabouts of which some barangays were not able to avail due to time constraints;


"RESOLVED, FURTHER, to furnish a copy of this resolution each to the Honorable Emeterio V. Larrazabal, OIC-City Mayor, the Honorable Benjamin B. Lladoc, OIC, Vice-Mayor & Presiding Officer, of the Sangguniang Panlungsod ng Ormoc, the City Development & Management Officer, MLG Ormoc Branch Office, all in Ormoc City;
