A RESOLUTION AUTHORIZING THE CITY TREASURER TO CHARGE AGAINST CURRENT APPROPRIATION THE SUM OF THREE THOUSAND SIX HUNDRED FORTY HESOS (\$3,640.00) FOR PAYMENT OF OUTSTANDING OBLIGA-TION OF THE CITY ENGINEER'S OFFICE OF 4 pcs. TIRES WITH INNER TUBES FOR USE OF FORD FIERA RP JEEP, WITH EBR MARKET-ING, SUBJECT HOWEVER TO THE SUBMISSION OF THE SUPPORTING PAPERS.
