A RESOLUTION EARNESTLY REQUESTING HER EXCELLENCY, PRESIDENT CORAZON C. AQUIND, THROUGH THE MINISTRY OF LOCAL SOVERNMENT, TO GRANT REPRESENTATION ALLOWANCES TO THE OIC VICE- MAYOR AND MEMBERS (KAGAWADS) OF THE SANGGUNIANG PANLUNGSOD NG ORMOC AT MONTHLY RATES WHICH ARE JUST AND PROPER FOR THEIR POSITIONS.

"WHEREAS, in the 1986 budget of the previous administration which is still in effect, there is an outstanding appropriation for representation allowances of the Vice-Mayor in the amount of P4,200.00 and for the Members (Kagawads) of the Sangguniang Panlungsod ng Ormoc in the amount of P42,000.00, respectively;

"WHEREAS, the Third Sangguniang Panlungsod ng Ormoc believes that the Vice-Mayor who is the Presiding Officer and the Members (Kagawads) be granted representation allowances considering their positions being equal to the Department Heads;

"WHEREAS, it is obvious that these officials are facing several requests for monetary contributions from their constituents especially for various affairs including the fencing of school campuses where they are donating certain sum of money for the said expenses;

NOW, THEREFORE, on motion of Kagawad Suan, unanimously seconded;

"RESOLVED, to earnestly request Her Excellency, President Corazon C. Aquino, through the Ministry of Local Government, to grant representation allowances to the OIC-Vice-Mayor and Members (Kagawads) of the Sangguniang Panlungsod ng Ormoc at monthly rates which are just and proper for their positions;
