RESOLUTION NO. 112

A RESOLUTION REQUESTING THE HONORABLE DIC-CITY MAYOR EMETERIO V. LARRAZABAL TO INTERCEDE IN BEHALF OF THE RESIDENTS OF SITIO MAANAHAW, BARANGAY BANTIGUE TO REQUEST THE MANAGEMENT OF LEYECO V TO INSTALL ELECTRIC POWER LINES FROM THE HIGHWAY MAIN LINE TO SAID SITIO.

"WHEREAS, the Sangguniang Panlungsod ng Ormoc is in receipt of Resolution No. 2, series of 1986 of the Sangguniang Pambarangay of Bantigue requesting Honorable DIC-Mayor Emeterio V. Larrazabal, through this Body to intercede in behalf of the residents of Sitio Maanahaw, Barangay Bantigue, this city for the installations of electrical lines from the highway to the respective houses in said sitio;

"WHEREAS, Resolution No. 2, states that the residents due to their willingness and/or desire to install electric lights in their respective houses, requested the Sangguniang Pambarangay of Bantigue to make representation with the Sangguniang Panlungsod, so that Leyeco V will install electrical lines within their locality;

"NOW, THEREFORE, on motion of Kagawad Fiel, seconded by Kagawads Yrastorza and Subingsubing; be it

"RESOLVED, to request Honorable DIC-City Mayor Emeterio V. Larrazabal to intercede in behalf of the residents of Sitio Maanahaw, Barangay Bantigue, to request the Management of Leyeco V to install electrical power lines from the highway main line to said sitio.
