MECS DIVISION OF DISTRICTING.

"WHEREAS, it is about time to divide the barangays of Ormoc City
into East, West, North and South Districts for administrative purposes
which has been tested very effective especially by the example of the
Ministry of Education, Culture and Sports, where they have also divided
the schools into East, West, North and South Districts;

"WHEREAS, Kagawad Sumaljag manifested that the division of
districts of Ormoc City which is patterned to that of the MECS would not
conflict nor affect the districting of the Kagawads embodied in
Resolution No. 8, dated May 20, 1986 dividing Ormoc City into 10
Representative Districts including the Vice-Mayor & Presiding Officer;

Kagawad Yrastorza; be it
