A RESOLUTION AUTHORIZING THE HONORABLE OIC-CITY MAYOR EMETERIO V. LARRAZABAL TO ACCEPT THE DONATION OF TWO (2) UNITS FLUORESCENT LIGHTING FIXTURES COMPLETE WITH ACCESSORIES TO BE INSTALLED AT BARANGAY 23, ORMOC CITY SUBJECT TO RESOLUTION NO. 1149 DATED APRIL 20, 1982.


