RESOLUTION NO. 115

A RESOLUTION AUTHORIZING THE HONORABLE DIC-CITY MAYOR EMETERIO V. LARRAZABAL TO ACCEPT THE DONATION OF EIGHT (8) FLUORESCENT LIGHTING FIXTURES, 20-WATT, 220 VOLTS, TO BE INSTALLED AT STRATEGIC PLACES IN BARANGAY 29, THIS CITY, SUBJECT TO RESOLUTION NO. 1149 DATED APRIL 20, 1982, LIMITING BARANGAY ELECTRIC CURRENT TO 250 WATTS, OTHERWISE ANY EXCESS OF WATTAGE WILL BE PAID BY THE BARANGAY OUT OF THEIR 10% REALTY TAX SHARES.

"WHEREAS, we are in receipt of Resolution No. 4, series of 1986 of the Sangguniang Pambarangay of Barangay 29, donating to the City Government of Ormoc eight (8) units fluorescent lighting fixtures, 20-watt, 220 volts, to be installed at strategic places in Barangay 29, and requesting that the power consumption be borne by the city government

"WHEREAS, said resolution states that the barangay residents of Barangay 29 are sometimes apprehensive due to the passage of unknown persons through the dark areas of the barangay;

"NOW, THEREFORE, on motion of Kagawad Hermosilla; seconded by Kagawad Subingsubing; be it

"RESOLVED, to authorize the Honorable DIC -City Mayor Emeterio V. Larrazabal to accept the donation of eight (8) units fluorescent lighting fixtures, 20-watt, 220 volts, to be installed at strategic places in Barangay 29, this city, subject to Resolution No. 1149 dated April 20, 1982, limiting barangay electric current to 250 watts, otherwise any excess of wattage will be paid by the barangay out of their 10% Realty Tax Shares;

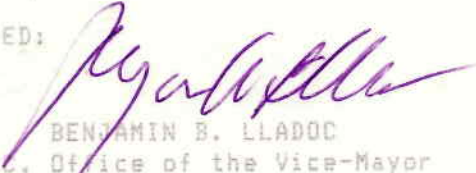
