RESOLUTION NO. 116

A RESOLUTION AUTHORIZING THE HONORABLE OIC-CITY MAYOR EMETERIO V. LARRAZABAL TO ACCEPT THE DONATION OF TWELVE UNITS (12) FLUORESCENT LIGHTING FIXTURES COMPLETE WITH ACCESSORIES TO BE INSTALLED AT BARANGAY LIBERTAD, THIS CITY, SUBJECT TO RESOLUTION NO. 1149 DATED APRIL 20, 1982.

"WHEREAS, the Sangguniang Pambarangay of Libertad in its Resolution No. 2, series of 1986 donating to the city government of Ormoc 12 units fluorescent lighting fixtures which will be used for street lighting and with a request that the payment of the power consumption bills be borne by the city government;

"WHEREAS, said barangay has requisitioned and appropriated an amount for the purchase of 12 units fluorescent lighting fixtures complete with mounting brackets, weather protectors, lead out wires and installation lag screws in order to prevent crimes against persons and property during the dark time in the evening;

"KNOW, THEREFORE, on motion of Kagawad Hermosilla; seconded by Kagawad Guan; be it

"RESOLVED, to authorize the Honorable OIC-City Mayor Emeterio V. Larrazabal to accept the donation of twelve (12) units fluorescent lighting fixtures complete with accessories to be installed at Barangay Libertad, this city, subject to Resolution No. 1149 dated April 20, 1982;

"RESOLVED, FURTHER, to furnish a copy of this resolution each to the City Treasurer, the Leyeco V, and the Sangguniang Pambarangay of Libertad, all in Ormoc City;
