RESOLUTION NO. 117

A RESOLUTION AUTHORIZING THE HONORABLE OIC-CITY MAYOR EMETERIO V. LARRAZABAL, TO ACCEPT THE DONATION OF TEN (10) UNITS FLUORESCENT LIGHTING FIXTURES, COMPLETE WITH ACCESSORIES TO BE INSTALLED AT THE STRATEGIC PLACES IN BARANGAY KADAQHAN, SUBJECT TO RESOLUTION NO. 1149, DATED APRIL 20, 1982.

"WHEREAS, we are in receipt of Resolution No. 2, series of 1986 of the Sangguniang Panbarangay of Kadaohan, earnestly requesting the Honorable OIC-City Mayor, through this august Body to receive donation of ten (10) units flourescent lighting fixtures and further request that the power consumption of said units which will be installed in strategic places in the barangay, be borne by the City government;

"WHEREAS, Resolution No. 2, states that the residents of said barangay have manifested their apprehension on the presence or passage through the barangay of persons who could not be identified due to the darkness of the barangay;

"NOW, THEREFORE, on motion of Kagawad Hermosilla; seconded by Kagawad Suan; be it

"RESOLVED, to authorize the Honorable OIC-City Mayor Emeterio V. Larrazabal, to accept the donation of barangay Kadaohan of ten (10) units flourescent lighting fixtures, complete with accessories to be installed at the strategic places of said Barangay, subject to Resolution No. 1149 dated April 20, 1986.


