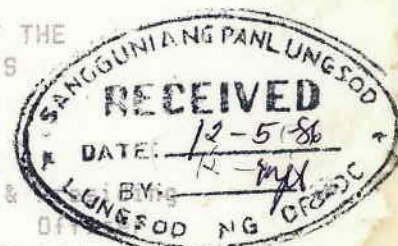

RESOLUTION NO. 120

A RESOLUTION REQUESTING THE HONORABLE MINISTER OF THE BUDGET TO GIVE  
NATIONAL AID TO LOCAL SCHOOLS OF ORMOC CITY CONSIDERING THE  
DEFICIENCY OF PAYMENT OF REAL PROPERTY TAX.

"WHEREAS, this august Body is in receipt of a Certification from  
the City Treasurer certifying the actual collections from the Special  
Education Fund (SEF) for the period from January, 1986 to October, 1986  
which is Six Hundred Fifty-Four Thousand One Hundred Forty-Seven Pesos &  
58/100 (P654,147.58) only representing 54.51% of the budgetary estimate  
of One Million Two Hundred Thousand Pesos (P1,200,000.00);

"WHEREAS, on November 24, 1986 the Secretary of this august Body  
wrote a letter to the City Treasurer requesting the monthly breakdown of
