A RESOLUTION TO ADOPT RESOLUTION NO.219, SERIES OF 1986 OF THE SANGGUNIANG PANLALAWIGAN OF PALAWAN, STRONGLY RECOMMENDING HER EXCELLENCY, PRESIDENT CORAZON C. AQUINO, CONFORMABLY WITH THE OFFICIAL STAND OF THE COMMISSION ON ELECTIONS NOT TO HOLD A SYNCHRONIZED ELECTIONS FOR CONGRESSIONAL AND LOCAL OFFICIALS NEXT YEAR.

"WHEREAS, the Honovie Sangguniang Panlalawigan of Palawan has furnished this august Body for information and support a copy of Resolution No. 219, series of 1986, strongly recommending Her Excellency, President Corazon C. Aquino, conformably with the official stand of the Corasissian on Elections not to hold a synchronized elections for congressional and local officials next year;

"WHEREAS, we concur in the embodiment of said resolution even as we uphold the disadvantages sighted therein that in the synchronized elections the will of the voters might not be correctly reflected in the official ballots considering the number of candidates to be chosen and be voted upon coupled with the time element involve if one does not write fast enough and the huge amount that will be incurred which might remembersly deplayed our national coffers;
