"WHEREAS, it has been observed that many notices intended for the public to know have passed unnoticed and not properly disseminated;

"WHEREAS, the right of the public to know important notices can not be over-emphasized considering that an uninformed public seldom reacts to important issues of the day, not to mention important legal notices and other notices which need to be broadly disseminated;

"NOW, THEREFORE, on motion of Kagawad Hermosilla, seconded by Kagawad Redona; be it

"RESOLVED, AS IT IS HEREBY RESOLVED; to pass a resolution earnestly requesting the Honorable OIC-City Mayor, Emeterio V. Larrazabal, to cause the design, construction and installation of a lighted bulletin board to be installed in a convenient and conspicuous place for public dissemination of notices;

"RESOLVED, FURTHER, to furnish a copy of this resolution each to the City Treasurer, the City Budget Officer and the City Engineer, all in Ormoc City;

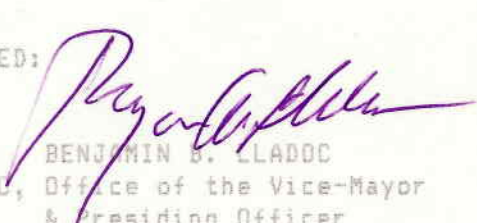
