HERMOSILLA WITH THE CITY TREASURER, CITY AUDITOR, CITY ENGINEER AND MEMBERS OF THE THIRD SANGGUNIANG PANLUNGSOD, AS MEMBERS.

"WHEREAS, it has been observed that some quotations for repairs and purchases of replacement parts and/or accessories are abnormally high due to the absence of standards of comparison and in-depth expertise in the landling of the maintenance and repair of the City Government's mechanical equipments;

"WHEDERS masong the august Members of the Third Sangguniang Panlungsod there is one member who has had expertise and experience in this particular kind of business, the automotive repair business, since the year 1946, or roughly 37 years and aside from the foregoing experience he has had also been an authorized and accredited service personne? For national and international companies dealing in automotive and heavy equipment, in the person of the Honorable Romeo M. Hermosilla, ABC President and member of the Third Sangguniang Panlungsod ng Ormoc;

NOW. THEREFORE, on motion of Kagawad Sumaljag, jointly seconded by Kagawads Redona and Subingsubing; be it

"RESOLVED, to create a special committee to screen or review applications for repairs and purchases of replacement parts and/or accessories of mechanized equipments of the City of Ormoc, to be chaired by the Honorable Romeo M. Hermosilla with the City Treasurer, City Auditor, City Engineer and Members of the Third Sangguniang Panlungsod and Ormoc, as Members;
