RESOLUTION NO. 124

A RESOLUTION TO REESTABLISH THE BARANGAY SITE OF BARANGAY DANAO IN CONFORMITY WITH THE PHILIPPINE NATIONAL OIL COMPANY'S REQUIREMENTS BECAUSE THE PNOC IS THE GUARDIAN OF THE NATIONAL RESERVATION UNDER WHICH SAID BARANGAY IS SITUATED SO AS TO DETERMINE THE EXACT LOCATION OR DISTANCE OF LAKE DANAO AND TO FURTHER REQUEST THE COMELEC TO INSTALL A PRECINCT IN THIS BARANGAY FOR THE COMING REGISTRATION AND PLEBISCITE AND FURTHERMORE, TO AUTHORIZE THE HONORABLE DIC CITY MAYOR EMETERIO V. LARRAZABAL TO APPOINT A NEW SET OF BARANGAY OFFICIALS.

"WHEREAS, Kagawad Antero T. Fiel reported that he met the former barangay officials together with some residents of Barangay Danao and requested him to sponsor a resolution to reestablish the barangay site which was abolished during the former administration where the residents were forcibly driven out of the old site and were resettled and some of them migrated to other far barangays up to Gaas, Cabingtán, Milagro and Sitio Cambantug;

"WHEREAS, in addition thereto one of the requests of some of barangay residents is for the COMELEC to establish or install a Precinct in their barangay and according to them they are over 300 voters/registrants who are willing to register but they will not do so if there is no precinct in said barangay if they have to go to Cabingtán or Milagro because it is very far;

"WHEREAS, this august Body intimates that the Honorable DIC-City Mayor Emeterio V. Larrazabal will have to appoint a new set of barangay officials for the good and welfare of its constituents and for the smooth operation of its barangay government;

"WHEREAS, according to Mr. Silvestre Valencia, Senior Local Development Officer of MLG, Ormoc City, Barangay Danao is still officially existing as a barangay and is still included in the list of

barangays in the records of MLG, Manila, MLG Regional Office in Tacloban City, and of course MLG, Ormoc City;

"NOW, THEREFORE, on motion of Kagawad Fiel, seconded by Kagawad Hermosilla; be it

"RESOLVED, to reestablish the barangay site of Barangay Danao in conformity with the Philippine National Oil Company's requirements because the PNOG is the guardian of the national reservation under which said barangay is situated so as to determine the exact location or distance from Lake Danao and to further request the COMELEC to install a Precinct in this barangay for the coming registration and plebiscite and furthermore, to authorize the Honorable OIC-City Mayor Emeterio V. Larrazabal to appoint a new set of barangay officials;

"RESOLVED, FURTHER, to furnish a copy of this resolution each to His Honor OIC-City Mayor Emeterio V. Larrazabal, the City Elections Registrar, COMELEC, and all concerned, all in Ormoc City;

"CARRIED UNANIMOUSLY."
