RESOLUTION NO. 125

A RESOLUTION EARNESTLY REQUESTING THE REGIONAL DIRECTOR PORFERIO P. SIAYNGCO OF THE LOCAL GOVERNMENT TO GRANT AUTHORITY TO UTILIZE AN AMOUNT OF P95,000.00 FROM THE 20% ECONOMIC DEVELOPMENT FUND FOR INFORMATION DRIVE ON RATIFICATION OF THE CONSTITUTION AND FOR COUNTER-INSURGENCY PROGRAM OF THE CITY GOVERNMENT OF ORMOC.

"WHEREAS, February 2, 1987 is the scheduled date for a Plebiscite for ratification of the Constitution as the fundamental law of the land;

"WHEREAS, it is apparent to have a counter-insurgency program for purposes of disseminating information drive to the people in the rural areas to keep them abreast of any precaution or agitation for the insurgents infiltration in our locality;

"NOW, THEREFORE, on motion of Kagawad Redona, seconded by Kagawad Sumaljag; be it

"RESOLVED, to earnestly request the Regional Director Porferio P. Siayngco of the Local Government to grant authority to utilize an amount of P95,000.00 from the 20% Economic Development Fund for information drive on ratification of the Constitution and Counter-insurgency Program of the City Government of Ormoc;

"RESOLVED, FURTHER, to furnish a copy of this resolution to Honorable Porferio P. Siayngco, Regional Director, Ministry of Local Government, Tacloban City, for his consideration and approval;


