RESOLUTION NO. 126

A RESOLUTION AUTHORIZING THE HONORABLE OIC-CITY MAYOR EMETERIO V LARRAZABAL, IN BEHALF OF THE CITY GOVERNMENT OF ORMOC TO SIGN A DEED OF ABSOLUTE SALE WITH MR. HERCULANO D. GARCIA, COVERING 639 SQUARE METERS OF THE LATTER'S LOT NO. 2347-B-6-B-1, SITUATED AT BARANGAY PUNTA, AT THE RATE OF P20.00 PER SQUARE METER, AS APPRAISED BY THE ASSESSMENT DEPARTMENT BASED ON THEIR SCHEDULES OF MARKET VALUES.

"WHEREAS, this august Body receives series of indorsements regarding the Road-right-of-way claim of Mr. Herculano D. Garcia for Lot No. 2347-B-6-B-1 with an area of 639 square meters, covered by an assessment under Tax Declaration No. 26593, situated at Barangay Punta, this city;

"WHEREAS, on the basis of an ocular inspection conducted by the representatives of the Office of the Assessment Department and in accordance with their Schedules of Values now in force, the fair market value of Lot. No. 2347-B-6-B-1, situated at Barangay Punta is at the rate of P20.00 per square meter, classified as dirt road;

"WHEREAS, this claim needs Deed of Absolute Sale to be signed by the Honorable OIC-City Mayor, in behalf of the City Government of Ormoc and Mr. Herculano D. Garcia covering the latter's Lot. No. 2347-B-6-B-1, situated at Barangay Punta, this city;

"NOW, THEREFORE, on motion of Kagawad Salazar, seconded by Kagawad Hermosilla; be it

"RESOLVED, to authorize the Honorable OIC-City Mayor Emeterio V. Larrazabal, in behalf of the City Government of Ormoc to sign a Deed of Absolute Sale with Mr. Herculano D. Garcia, covering 639 square meters of the latter's Lot No. 2347-B-6-B-1, situated at Barangay Punta, this

City, at the rate of P20.00 per square meter, as appraised by the Assessment Department based on their Schedules of Market Values;


