RESOLUTION NO. 129

A RESOLUTION AUTHORIZING THE HONORABLE DIC-CITY MAYOR EMETERIO V. LARRAZABAL TO SIGN A DEED OF SALE FOR AND IN BEHALF OF THE CITY OF ORMOC AFFECTING PORTION OF LOT NO. 2219 OF EX-CONGRESSMAN DOMINADOR M. TAN, REPRESENTED BY THE LATTER'S ATTORNEY-IN-FACT MR. FERNANDO M. TAN, WITH AN AREA OF 711 SQUARE METERS, COVERED BY TCT NO. 105 TRAVERSED BY FAUSTINO ABLEN CITY STREET.

"WHEREAS, City Engineer Ruben C. Penserga of Ormoc has forwarded to this august Body, through the Honorable Chairman on Public Properties a Road Right-of-Way claim of Mr. Fernando M. Tan, Attorney-In-Fact of Ex-Congressman Dominador M. Tan, affecting portion of Lot No. 2219, situated at Barangay Cogon, this city, traversed by Faustino Ablen city street;

"WHEREAS, per same indorsement, the exact area used by the city is 711 square meters;

"WHEREAS, per appraisal of said lot by the Office of the City Assessor, the fair market value is at the rate of P70.00 per square meter based on the Schedule of Market Values obtaining in 1978;

"NOW, THEREFORE, on motion of Kagawad Suan, seconded by Kagawad Sumaljag; be it

"RESOLVED, to authorize the Honorable DIC-City Mayor Emeterio V. Larrazabal to sign a Deed of Sale for and in behalf of the City of Ormoc affecting portion of Lot. No. 2219 of Ex-Congressman Dominador M. Tan, represented by the latter's Attorney-In-Fact Mr. Fernando M. Tan, with an area of 711 square meters covered by TCT No. 105 traversed by Faustino Ablen city street;
