RESOLUTION NO. 137

A RESOLUTION EARNESTLY REQUESTING THE HONORABLE OIC-CITY MAYOR TO FAVORABLY ENDORSE TO THE CITY ENGINEER THE REPAIR OF NAYOG-OLD AIRPORT-LAO BARANGAY ROAD AND ALSO TO FAVORABLY INTERCEDE FOR AND IN BEHALF OF BARANGAY LIBERTAD FOR THE INSTALLATION OF ELECTRICAL LINES TO SITIO NAYOG.

"WHEREAS, this august body is in receipt of Resolution No. 2, s. 1986 of the Sangguniang Pambarangay of Libertad requesting the Honorable OIC-City Mayor, through the Chairman on Infrastructure and the Kagawad In-Charge of Barangay Libertad to cause the repair of the Nayog-Old Airport-Lao barangay road and to intercede for the installation of electrical power posts for mainlines to Sitio Nayog by Leyeco V;

"WHEREAS, said resolution states that barangay road from Sitio Nayog of Barangay Libertad to Barangay Lao is already badly damaged due to the several stormy weather which rendered the road unpassable thereby causing inconvenience to the transportation of products from the farm to market;

"NOW, THEREFORE on motion of Kagawad Hermosilla, seconded by Kagawad Salazar; be it

"RESOLVED, to earnestly request the Honorable OIC-City Mayor to favorably endorse the City Engineer the repair of the Nayog-Old Airport-Lao barangay road and also to favorably intercede for and in behalf of said barangay for the installation of electrical lines to Sitio Nayog by Leyeco V;

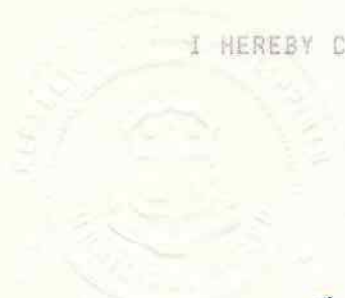
