RESOLUTION NO. 15

A RESOLUTION AUTHORIZING THE HONORABLE OFFICER IN-CHARGE, CITY
MAYOR'S OFFICE, THIS CITY, TO ACCEPT THE DONATION OF 5 SETS
OF FLUORESCENT LIGHTING FIXTURES OF 20-WATT, 220 VOLTS, WITH
WEATHER PROTECTORS AND MOUNTING ATTACHMENTS BY MR. TEOFILO M.
FRAN TO BE INSTALLED AT STRATEGIC AREAS AROUND BARANGAY MARGEN
AND THANKING THE DONOR FOR HIS CIVIC-MINDEDNESS, SUBJECT TO
RES. NO. 1149 S. 1982 LIMITING BARANGAY ELECTRIC CURRENT TO
ONLY 250-WATT, OTHERWISE, ANY EXCESS OF WATTAGE WILL BE PAID
BY THE BARANGAY OUT OF THEIR 10% REALTY TAX SHARES.

"The Sangguniang Panlungsod ng Ormoc, on motion of Kagawad
Hermosilla, seconded by Kagawad Salazar; be it

"RESOLVED, to authorize the Honorable Officer In-Charge,
City Mayor's Office, to accept the donation of 5 sets of fluo-
rescent lighting fixtures of 20-watt, 220 volts, with weather
protectors and mounting attachment by Mr. Teofilo M. Fran to be
installed at strategic areas around Barangay Margen and thanking
the donor for his civic-mindedness, subject to Resolution No.
1149, s. 1982, limiting barangay electric current to only 250-watt,
otherwise, any excess of wattage will be paid by the barangay out
of their 10% realty tax shares.

"RESOLVED, FURTHER, to furnish a copy of this resolution each
to the City Treasurer, the Sangguniang Pambarangay of Margen, Mr.
Teofilo M. Fran, barangay Margen, all of Ormoc City;

CARRIED UNANIMOUSLY."
