RESOLVED, to adopt:

APPROPRIATION ORDINANCE NO. 86-3
(Infrastructure Fund)

BE IT ENACTED, by the Sangguniang Panlungsod ng Ormoc, That:

SECTION 1. 1986 Infrastructure Fund Supplemental Budget. -- The Infra-structure Fund Supplemental Budget of Ormoc City for calendar year 1986 with a total appropriation of SIXTY THOUSAND NINE HUNDRED PESOS (P60,900.00) for purposes therein specified out of funds therefore provided in the aggregate sum of SIXTY THOUSAND NINE HUNDRED PESOS (P60,900.00) be as it is hereby, APPROVED.

SECTION 2. Effectivity. -- This Appropriation Ordinance shall take effect immediately upon its approval.

RESOLVED, FURTHER, that at least three copies of this Appropriation-Ordinance together with the approved supplemental budget and all supporting schedules, be submitted, through the City Budget Officer to the Ministry of Budget for review;
