BE IT ENACTED, by the Sangguniang Panglungsod ng Ormoc, That:

SECTION 1. 1986 General Fund Supplemental Budget. - The General Fund Supplemental Budget of Ormoc City for calendar year 1986 with a

total appropriation of THIRTY-TWO THOUSAND FOUR HUNDRED NINETY-NINE PESOS & 07/100 (P32,499.07) for purposes therein specified out of funds therefor provided in the aggregate sum of THIRTY-TWO THOUSAND FOUR HUNDRED NINETY-NINE PESOS & 07/100 (P32,499.07) be, as it is hereby, APPROVED.

SECTION 2. Effectivity. - This Appropriation Ordinance shall take effect immediately upon its approval.

RESOLVED, FURTHER, that at least three copies of this Appropriation Ordinance, together with the approved General Fund Supplemental Budget and all supporting schedules, be submitted, through the City Budget Officer, to the Honorable Minister of the Budget for review;
