A RESOLUTION REQUIRING THE COMELEC REGISTRAR, ORMOC CITY
TO FURNISH THE SANGGUNIANG PANLUNGSOD NG ORMOC THE
RESULT OF PLEBISCITE CONDUCTED AT ALTA VISTA.

"WHEREAS, this august Body has been reliably informed by the
residents of Alta Vista that the local COMELEC of this city has
already conducted a plebiscite to constitute Alta Vista as a
barangay of Ormoc City;

"WHEREAS, Sangguniang Panlungsod Secretary by authority of
the august Body made a query to the City Election Registrar and
the Senior Local Government Officer, Ministry of Local Govern-
ment both of this city as to the legal status of Alta Vista and
other pertinent matters relative therein;

NOW, THEREFORE, on motion of Kagawad Salazar, seconded by
Kagawad Hermosilla; be it

"RESOLVED, to respectfully require the COMELEC Registrar of
this city to furnish the Sangguniang Panlungsod ng Ormoc the
result of the Plebiscite conducted at Alta Vista;

"RESOLVED, FURTHER, to furnish a copy of this resolution
each to the COMELEC Election Registrar, the MLG Senior Local
Government Officer and the residents of Alta Vista, all in Ormoc
City;
