RESOLUTION NO. 1873

A RESOLUTION EARNESTLY REQUESTING HIS EXCELLENCY, PRESIDENT
FERDINAND E. MARCOS THROUGH THE HONORABLE MINISTER OF
JUSTICE FOR AN ADDITIONAL TWO (2) POSITIONS AS ASSIST-
TANT CITY FISCALS FOR ORMOC CITY.

"WHEREAS, this august Body has noted with concern the number of criminal
cases handled by the prosecution service of the City Government of Ormoc;

"WHEREAS, diligent efforts had always been exerted by the City Fiscal's
Office of Ormoc City to case out and dispose cases filed with this Office
with the end in view that speedy administration of justice shall be achieved;

"WHEREAS, considering that the prosecution service in Ormoc City is under-
manned, there is an urgent need to add at least two (2) Assistant City Fiscals
to avoid backlog of criminal cases and enhance the speedy administration of
justice;

"NOW, THEREFORE, on motion of Kagawad Besabella, jointly seconded by Kaga-
wad Mendola and Larrazabal; be it

"RESOLVED, to earnestly request His Excellency, President Ferdinand E.
Marcos, through the Honorable Minister of Justice for an additional two (2)
positions as Assistant City Fiscals for Ormoc City;

"RESOLVED, FURTHER, to furnish a copy of this resolution each to His
Excellency, President Ferdinand E. Marcos, Malacañang; the Honorable Minister
of Justice, both of Metro Manila; and the City Fiscal, Ormoc City;

"CARRIED UNANIMOUSLY."
