RESOLUTION NO. 1875

A RESOLUTION INTERPOSING NO OBJECTION TO THE APPLICATION FOR TITLING PURPOSES OF THE PUBLIC LANDS, ON A CASE TO CASE BASIS, SITUATED AT BARANGAY DISTRICTS 17,23 AND BARANGAY SAN ISIDRO (RELOCATION SITE-PHASE II), THIS CITY, CONSIDERING, THAT THE CITY GOVERNMENT DOES NOT NEED THESE LANDS FOR PUBLIC IMPROVEMENTS, PROVIDED THAT ALL OTHER REQUIREMENT SHALL HAVE BEEN COMPLIED WITH;

"WHEREAS, Kagawad Mendola in his capacity as Chairman on Public properties manifested that Barangay Captains of Barangay Districts 17, 23 and Barangay San Isidro, this city, requested from this august Body a recommendation that they be allowed to secure titles of their lots which had been previously adjudicated to them;

"WHEREAS, this august Body finds no objection to their applications for titling purposes of the public lands situated at Barangay Districts 17,23 and Barangay San Isidro (Relocation site Phase II), this city, considering that the city government does not need these lands for public improvements, provided that same shall only be made applicable to original allocatees of the lots, as previously indicated by the City government of Ormoc, considering that there are occupants, presently, who are not original allocatees;

"NOW, THEREFORE, on motion of Kagawad Mendola unanimously seconded by all the rest of Mga Kagawad present; be it

"RESOLVED, to interpose no objection to the application for titling purposes of the public lands situated at Barangay Districts 17,23 and Barangay San Isidro (Relocation site Phase II), this city considering that the city government does not need these for public improvements; that this resolution shall be made only on a case to case basis-only to those original allocatees, as previously indicated by the city government;

"RESOLVED, FURTHER, to furnish a copy of this resolution each to the Minister of Natural Resources, Bureau of Lands, Manila; the District Land Officer, District Land Office No. VIII-I, Tacloban City; the City Engineer, and the Sangguniang Pambarangay of Districts 17,23 and Barangay San Isidro, all in Ormoc City;

"UNANIMOUSLY CARRIED."
