RESOLUTION NO. 1878.

A RESOLUTION AUTHORIZING THE HONORABLE ACTING CITY MAYOR TO SIGN A DEED OF SALE FOR AND IN BEHALF OF THE CITY OF ORMOC AFFECTING LOT NO. 2346-C OF JOSE D. ESMERO WITH AN AREA OF ONE THOUSAND EIGHTY-NINE (1,089) SQUARE METERS, MORE OR LESS COVERED BY TCT NO. 20095 TRAVERSED BY DON FELIPE LARRAZABAL ROAD.

"WHEREAS, this august Body is in receipt of a communication of Jose D. Esmero, claiming payment of his Lot No. 2346-C; TCT No. 20095, Tax Declaration No. 16410, covering an area of 1,089 sq. meters more or less situated at Barangay Punta traversed by Don Felipe Larrazabal city road;

"WHEREAS, this matter has been referred to the City Assessor for appraisal;

"WHEREAS, the City Assessor in his 2nd indorsement, dated June 10, 1985 informed that the fair market value of portion of Lot No. 2346-C is at the rate of ₱70.00 per sq. meter based on their Schedule of Market Values;

"WHEREAS, an authority of the Acting City Mayor is needed to sign Contract of Sale for and in behalf of the City of Ormoc for proper ownership of same;

"NOW, THEREFORE, on motion of Kagawad Torre Villas jointly seconded by Kagawad Mendola and Bandalan; be it

"RESOLVED, to authorize the Honorable Acting City Mayor to sign a Deed of Sale for and in behalf of the City of Ormoc affecting Lot No. 2346-C of Jose D. Esmero with an area of ONE THOUSAND EIGHTY-NINE (1,089) sq. meters, more or less covered by TCT No. 20095 traversed by Don Felipe Larrazabal City road;
