RESOLUTION NO. 1883 . Sco

A RESOLUTION INTERPOSING NO OBJECTION TO THE APPLICATION FOR TITLING PURPOSES OF THE PUBLIC LAND, ON A CASE TO CASE BASIS AT NEW SOCIETY VILLAGE, CAN-ADIENG, THIS CITY, CONSIDERING THAT THE CITY COVERNMENT DOES NOT NEED THIS LAND FOR PUBLIC IMPROVEMENTS; PROVIDED: HOWEVER, THAT ALL OTHER REQUIREMENTS SHALL HAVE BEEN COMPLIED WITH.

"WHEREAS, Kagawad Mendola, Chairman on Public Properties manifested that residents of New Society Village in Barangay Can-adieng, this city, have requested from this august Body, thru his Committee a recommendation that residents of New Society Village, Can-adieng, Ormoc City, be allowed to secure titles of their lots which had previously been adjudicated to them:

"WHEREAS, the City Government of Ormoc does not need this land f o r public improvements purposes, hence, it interposes no objection to their titling of their respective lots, on a case to case basis - only to those original allocatees, as beneficiaries, as previously indicated by t h e City Government, as there are now occupants of certain portions of the lots who are not allocatees;

"NOW, THEREFORE, on motion of Kagawad Mendola, seconded by Kagawad Larrazabal; be it

RESOLVED, to interpose no objection to the applications for titling purposes of the public land situated at New Society Village, Barangay Canadieng, this city, considering that the City Government of Ormoc does not need anymore this land forpublic improvements; Provided, However, that all other requirements set by law shall have been complied with and that this resolution shall only be applicable to original allocatees of said lots;
