RESOLUTION NO. 1888

A RESOLUTION TO RECALL RESOLUTION NOS. 1875 AND 1883 DATED JANUARY 14, AND FEBRUARY 4, 1986, RESPECTIVELY APPERTAINING TO THE APPLI-CATIONS FOR TITLING PURPOSES OF THE PUBLIC LANDS, SITUATED AT BARANGAY DISTRICT 17, 23, BARANGAY SAN ISIDRO (RELOCATION SITE PHASE II) AND AT NEW SOCIETY VILLAGE OF BARANGAY CAN-ADIENG, ALL OF THIS CITY.

"WHEREAS, on January 14, 1986 this august Body passed and approved Resolution No. 1875 interposing no objection to the appli-cation for titling purposes of the public land, on a case to case basis, situated at Barangay Districts 17, 23 and Barangay San Isidro (Relocation Site Phase II), considering that the city government does not need these lands for public improvements, Provided, that all other requirements shall have been complied with;

"WHEREAS, on February 4, 1986 this august Body passed and approved again Resolution No. 1883 interposing no objection to the application for titling purposes of the public land, also, on a case to case basis, at New Society Village, Can-adieng, with same reason;

"WHEREAS, considering the need for a further consideration on the matters as contained, in Resolution Nos. 1875 and 1883, of current series; this Body deems it proper to recall said resolutions;

"NOW, THEREFORE, on motion of Kagawad Mendola, unanimously seconded by all the rest of the Kagawad present; be it

"RESOLVED, to recall Resolution Nos. 1875 and 1883 dated Janua-ry 14 and February 4, 1986, respectively appertaining to the applica-tions for titling purposes of the public lands, situated at Barangay District Nos. 17, 23, Barangay San Isidro (Relocation site Phase II) and at New Society Village of Barangay Can-adieng, all of this city;

"RESOLVED, FURTHER, to furnish a copy of this resolution each to the Bureau of Lands, Manila; the District Land Officer, District Land Office No. VIII-I, Tacloban City; the City Engineer, the Sang-gunian Pambarangay of Districts 17, 23 and Barangays San Isidro and NSV, Can-adieng, all in Ormoc City;

"CARRIED UNANIMOUSLY."
