RESOLUTION NO. 1889

A RESOLUTION INTERPOSING NO OBJECTION TO THE APPLICATION FOR TIT-LING PURPOSES OF THE PUBLIC LAND, ON A CASE TO CASE BASIS, SIT TUATED AT BARANGAY DISTRICT 17, THIS CITY, CONSIDERING THAT THE CITY GOVERNMENT DOES NOT NEED THIS LAND FOR PUBLIC IMPROVEMENT, PROVIDED THAT ALL OTHER REQUIREMENTS SHALL HAVE BEEN COMPLIED WITH.

"WHEREAS, Kagawad Mendola in his capacity as Chairman on Public Properties manifested that the residents and occupants of the lots in Barangay District 17, have requested from this august Body a recommendation that they be allowed to secure titles of their respective lots which had previously been adjudicated to them;

"WHEREAS, this august Body interposes no objection to the request of the said occupants considering that the city government does not need this land anymore for public improvement, provided that same shall only be on a case to case basis and only to the original allocatees of the lots, a s previously indicated by the dity Government of Ormoc, considering that there are present occupants, who are not original allocatees of the said lots;
