RESOLUTION NO. 1894

A RESOLUTION INTERPOSING NO OBJECTION TO THE APPLICATIONS FOR TITLING PURPOSES OF THE PUBLIC LANDS; ON A CASE TO CASE BASIS, SITUATED AT BARANGAYS 23; SAN ISIDRO (RELOCATION SITE, PHASE II) AND AT NEW SOCIETY VILLAGE, CAN-ADIENG; ALL OF ORMOC CITY, CONSIDERING THAT THE CITY GOVERNMENT DOES NOT NEED THESE LANDS FOR PUBLIC IMPROVEMENTS, PROVIDED THAT ALL OTHER REQUIREMENTS SHALL HAVE BEEN COMPLIED WITH.

"WHEREAS, Kagawad Mendola in his capacity as Chairman on Public Properties manifested that Barangay residents of Barangay District 23; San Isidro, (Relocation site, Phase II), and New Society Village, Can-adieng; all of this city, have requested from this august Body, a recommendation that they be allowed to secure titles of their lots which had been previously adjudicated to them;

"WHEREAS, the Sangguniang Panlungsod ng Ormoc interposes no objection to the request of the said occupants or applicants considering that the city government does not need this land anymore for public improvements, PROVIDED, However, that same shall only be on a case to case basis and only to the original allocatees of the lots, as previously indicated by the City government of Ormoc, and are actual occupants of the same.

"NOW, THEREFORE, on motion of Kagawad Mendola, seconded by all the rest of the Kagawad present; be it

"RESOLVED, to interpose no objection to the applications for titling purposes of the public lands, on a case to case basis, situated at Barangays 23; San Isidro (Relocation site, Phase II), and New Society Village, Can-adieng, all of this city, considering that the city government does not need these lands for public improvements, PROVIDED, However, that all other requirements set by law shall have been complied with and that this resolution shall only be applicable to original allocatees of said lots and are actual occupants of the same.

"RESOLVED, FURTHER, to furnish a copy of this resolution each to the Bureau of Lands, Manila; the District Land Officer, District Land Office No. VIII-1, Tacloban City; the City Engineer, and the Sangguniang Pambarangays of District 23, San Isidro, and Can-adieng, all in Ormoc City;

"CARRIED UNANIMOUSLY."
