RESOLUTION NO. 1896

A RESOLUTION INFORMING THE COMMISSION ON ELECTIONS (COMELEC) THIS CITY, OF THE CREATION OF NEW BARANGAY ALTA VISTA PURSUANT TO LOCAL GOVERNMENT CODE, AND REQUESTING FURTHER THAT A PLEBESCITE BE CONDUCTED WITHIN 60 DAYS FROM APPROVAL OF ORDINANCE CREATING SAID BARANGAY.

"WHEREAS, this august Body had passed and approved Ordinance No. 49 entitled "An Ordinance Creating Barangay Alta Vista from out of Sitios Tunghan, Catoto-an and Patag Squatters Relocation Site, part of Barangay Patag with seat of government at Sitio Patag Squatters relocation site;

"NOW, THEREFORE, on motion of Kagawad Mendola, jointly seconded by Kagawad Besabella and Alfaro; be it

"RESOLVED, to inform the Commission on Elections (COMELEC) this city, of the creation of new Barangay Alta Vista pursuant to Local Government Code, to request further that a plebescite be conducted within 60 days from the approval of the measure creating said barangay;

"RESOLVED, FURTHER, to furnish a copy of this resolution each to the Commission on Elections (COMELEC), Manila, the City Election Registrar, the City Development and Management Officer, both of Ormoc City;

"CARRIED UNANIMOUSLY".
