RESOLUTION NO. 1899

A RESOLUTION INTERPOSING NO OBJECTION TO THE TITLING OF LOT NO. 2221-A-1-A, WITH AN AREA OF 234 SQUARE METERS IN FAVOR OF RAFAEL CARCAGENTE CONSIDERING THAT THE SAID LOT IS NOT ONE AMONG THOSE SUBJECT FOR EXPROPRIATION BY THE CITY GOVERNMENT AND NOT AFFECTED BY THE OSMEÑA EXTENSION ALTHOUGH IT IS ALONG A CITY STREET.

"WHEREAS, Rafael Carcagente in his letter of December 23, 1985 has requested that he be granted approval for titling purposes of Lot No. 2221-A-1-A, with an area of 234 sq. meters, portion of Lot No. 2221, situated at Barangay Cogon, this city;

"WHEREAS, this august Body through its Asst. Board Secretary endorsed same to the Honorable Chairman on Public Properties for study, comment and recommendation;

"WHEREAS, Kagawad Mendola, Chairman on Public Properties endorsed it to the City Engineer for comment and recommendation;

"WHEREAS, the City Engineer, in his returned indorsement dated March 7, 1986 stated among others, that after the government had established and/or plotted the area intended for the City Development Road and the circumferential government center site, as well, a portion of Lot No. 2221 (i.e. Lot No. 2221-A-1-A) was unaffected or in excess of what the government needed, and in addition thereto the city Geodetic Engineer has certified that the said lot is not among those subject to the Expropriation Proceedings by the City, in the government center site;

"NOW, THEREFORE, on motion of Kagawad Mendola, seconded by Kagawad Hermosilla: be it

"RESOLVED, to interpose no objection to the titling of Lot No. 2221-A-1-A with an area of 234 sq. meters in favor of Rafael Carcagente considering that the said lot is not among those subject for expropriation by the City Government of Ormoc and not affected by the Osmeña Extension;

"RESOLVED, FURTHER, to furnish a copy of this resolution each to the Bureau of Lands, Manila; the District Land Officer, District Land Office No. VIII-I, Tacloban City; the City Engineer, and Mr. Rafael Carcagente, both of Ormoc City;

"CARRIED UNANIMOUSLY."
