RESOLUTION NO. 19

A RESOLUTION AUTHORIZING THE CITY TREASURER TO RELEASE THE SUM OF FIVE HUNDRED PESOS (P500.00) FROM OUT OF THE 10% BARANGAY SHARE OF QUEZON, JR. TO BE MADE AVAILABLE FOR DEATH BENEFITS OF THE SURVIVING HEIRS OF THE LATE BARANGAY KAGAWAD VIDAL M. YAHOT WHO DIED ON JUNE 1, 1986.

"WHEREAS, Appropriation Ordinance No. 1, s. 1986 of the Sangguniang Pambarangay of Quezon, Jr., among others, appropriating the amount of Five Hundred Pesos (P500.00) from barangay funds of Quezon Jr., to be used to pay the surviving spouse or legal heirs of the Late Vidal M. Yahot, incumbent kagawad ng Sangguniang Pambarangay of Quezon Jr., who expired June 1, 1986 at 3:00 A.M.

"WHEREAS, Section 94, Paragraph 3 of Batas Pambansa 337, mandates that 'The surviving spouse or legal heirs of every barangay official who dies during his incumbency shall be entitled to burial benefits chargeable against the general fund of the barangay in an amount not less than five hundred pesos. In the event the barangay funds are insufficient for this purpose, the same shall be chargeable against the funds of the city or municipality to which the barangay belongs.';

"NOW, THEREFORE, on motion of Kagawad Hermosilla, seconded by Kagawad Suan; be it

"RESOLVED, to authorize the City Treasurer to release the sum of Five Hundred Pesos (P500.00) from out of the 10% barangay share of Quezon, Jr. to be made available for death benefits of the surviving heirs of the Late Barangay Kagawad Vidal M. Yahot who died on June 1, 1986;

"RESOLVED, FURTHER, to furnish a copy of this resolution each to the City Treasurer, the City Budget Officer, the surviving heirs of the Late Vidal M. Yahot and the Sangguniang Pambarangay of Quezon Jr., all in Ormoc City;

"CARRIED UNANIMOUSLY."
