RESOLUTION NO. 1900

A RESOLUTION AUTHORIZING THE CITY TREASURER TO CHARGE AGAINST CURRENT APPROPRIATION ON WATER, ILLUMINATION & POWER SERVICES, OFFICE OF THE SANGGUNIANG PANLUNGSOD, ORMOC CITY, THE SUM OF FOURTEEN THOUSAND FOUR HUNDRED EIGHTY-THREE PESOS & 23/100 (P14,483.23) FOR PAYMENT OF OUTSTANDING OBLIGATION FOR ELECTRIC CONSUMPTION WITH LEYECO V, FOR THE MONTHS OF JULY-NOVEMBER, 1985.

"The Sangguniang Panlungsod ng Ormoc, on motion of Kagawad Besabella, seconded jointly by Kagawad Mendola and Alfaro; be it

"RESOLVED, to authorize the City Treasurer to charge against current appropriation on Water, Illumination & Power Services, Office of the Sangguniang Panlungsod, this city, the sum of FOURTEEN THOUSAND FOUR HUNDRED EIGHTY-THREE PESOS & 23/100 (P14,483.23), said sum or so much thereof as maybe necessary to be made available for payment of outstanding obligation for electric consumption with the Leyeco V, for the months of July-November, 1985.
