RESOLUTION NO. 1906

A RESOLUTION AUTHORIZING THE CITY TREASURER TO CHARGE AGAINST ITEM 385-SR. CIVIL ENGINEER (VALENTINO BADIYA), OFFICE OF THE CITY ENGINEER FOR THE PERIOD APRIL 1, 1986 TO DECEMBER 31, 1986, THE SUM OF P17,919.00 AND AGAINST APPROPRIATION ON OUTLAY FOR LEAVE CREDITS OF THE INFRASTRUCTURE FUND FOR THE PERIOD JANUARY 1, 1987 TO APRIL 30, 1987 THE SUM OF P7,964.00, TOTALLING P25,883.00, TO BE MADE AVAILABLE FOR FULL PAYMENT OF COMMUTATION OF SICK LEAVE OF ENGR. VALENTINO BADIYA.

"The Sangguniang Panlungsod ng Ormoc, on motion of Kagawad Besabella, jointly seconded by the Honorable Kagawad Torre Villas, Alfaro and Codilla; be it

"RESOLVED, to authorize the City Treasurer to charge against Item 385-SR. Civil Engineer (Valentino Badiya), Office of the City Engineer for the period April 1, 1986 to December 31, 1986 the sum of SEVENTEEN THOUSAND NINE HUNDRED NINETEEN PESOS (P17,919.00) and against appropriation on outlay for Leave Credits of the Infrastructure Fund for the period January 1, 1987 to April 30, 1987 the sum of SEVEN THOUSAND NINE HUNDRED SIXTY-FOUR PESOS (P7,964.00), totalling TWENTY FIVE THOUSAND EIGHT HUNDRED EIGHTY-THREE PESOS (P25,883.00), said sum or so much thereof as maybe necessary to be made available for full payment of commutation of sick leave of Engr. Valentino Badiya, Sr. Civil Engineer, City Engineer's Office;
