RESOLUTION NO. 1908

A RESOLUTION EXPRESSING THE VIEWS OF THIS BODY IN CONSONANCE
WITH SECTION 62(4) OF ORDINANCE NO. 10, S. 1969, OTHER-
WISE KNOWN AS THE MARKET AND SLAUGHTERHOUSE CODE OF
ORMOC CITY, IN CONNECTION WITH THE LETTER OF MR. HILA-
RIO E. HERMOSA.

"WHEREAS, this august Body is in receipt of communication dated
March 4, 1986 of Mr. Hilario E. Hermosa, District Postal Inspector, Bu-
reau of Posts, this city, requesting that he be exempted from the prohi-
bition of Ordinance No. 10, s. 1969 specifically Section 62(4) prohibi-
ting the renters to sleep in or make any tienda, stall or booth, a s
sleeping quarters;

"WHEREAS, it is the consensus of the august Body to deny the request
considering that this might create a precedence; that it is the considered
opinion of this Body that the provisions of the aforecited ordinance should
be strictly enforced;

"NOW, THEREFORE, on motion of Kagawad Besabella, seconded by Kagawad
Fiel; be it

"RESOLVED, to express the views of this august Body in consonance with
Section 62(4) of Ordinance No. 10, s. 1969, otherwise known as the Market
and Slaughterhouse Code of Ormoc City;

"RESOLVED, FURTHER, to furnish a copy of this resolution each to the
City Treasurer, Mr. Hilario E. Hermosa, District Postal Inspector, Bureau
of Posts, and the Market Committee, all in Ormoc City;
