RESOLVED, to adopt:

APPROPRIATION ORDINANCE NO. 86-5
(Special Education Fund)

BE IT ENACTED, by the Sangguniang Panlungsod ng Ormoc, That:

SECTION 1. Creation of one (1) Teacher in the Ormoc City High School. - The position of one (1) teacher in the Ormoc City High School with compensation at the rate of TWELVE THOUSAND SIX HUNDRED THIRTY-TWO PESOS & 40/100 (P12,632.40) is hereby created, PROVIDED, HOWEVER, that funds for the purpose shall be provided in subsequent annual appropriation ordinance.

SECTION 2. Special Education Fund Supplemental Budget. - The Special Education Fund Supplemental Budget of Ormoc City for calendar year 1986 with a total appropriation of NINE THOUSAND THREE HUNDRED THIRTY-FOUR PESOS & 89/100 (P9,334.89) for purposes therein stated to be taken from out of the Special Education Fund in the amount of NINE THOUSAND THREE HUNDRED THIRTY-FOUR PESOS & 89/100 (P9,334.89) be, as it is hereby, APPROVED.

SECTION 3. Effectivity. - This Appropriation Ordinance shall take effect immediately upon its approval.


RESOLVED, FURTHER, that at least three copies of this Appropriation Ordinance, together with the approved Special Education Fund Supplemental Budget and all supporting schedules, be submitted, through the City Budget Officer, to the Honorable Minister of the Budget for review.
