RESOLUTION NO. 21

A RESOLUTION FAVORABLY RECOMMENDING THE REQUEST OF DR. HIROICHI ITO, REPRESENTATIVE, EX-KHAKI-CORPS, 9TH INFANTRY REGIMENT, VETERAN'S ASSOCIATION, 50-13, NOZATOCHO, KATSURA, NISHIKYO-KU, KYOTO CITY 615, JAPAN, TO PUT UP A MEMORIAL MONUMENT MARKER IN BARAN-GAY DOLORES ELEMENTARY SCHOOL, PROVIDED, HOWEVER, THAT THE ENGLISH TRANSLATION FOR FILIPINO, AMERICAN AND JAPANESE SOLDTERS, SHOULD BE WRITTEN ON IT.

"WHEREAS, Dr. Hiroichi Ito, Representative, Ex-Khaki-Corps, 9th Infantry Regiment, Veteran's Association, 50-13, Nozatocho, Katsura, Nishikyo-ku, Kyoto City 615, Japan in his letter off May 15, 1986, has requested the Honorable Emeterio V. Larrazabal, Officer In-Charge, City Mayor's Office for a permission to put up a memorial monument marker in the Elementary School in Dolores, Ormoc City, as a symbol and place for remembrance of thousands of soldiers who died during the Second World War in Leyte;

"MHEREAS, for purposes of this request the Honorable Committeeson: Education & Culture and Tourism & Cultural Development has conducted a joint conference on June 9, 1986 inviting Messers: Pedro N. Compendio, Division Superintendent of Schools; Emiliano Teves, Principal, Dolores Elementary School; Gerundio Sosmeña, Barangay Captain of Barangay Dolores, and Col Teofilo T. Moncada (Ret), Chapter Commander, Ormoc City & Western Leyte Chapter and American Legion, Post No. 47, Philippine Department, all of Ormoc City, for which they agreed that the said request be granted considering the great importance as a token memoir dedicated to our beloved soldiers who died for the sake of our country;
