APPROPRIATION ORDINANCE NO. 86-6

BE IT ENACTED, by the Sangguniang Panlungsod ng Ormoc, That:

SECTION 1. 1986 Infrastructure Fund Supplemental Budget. — The Infrastructure Fund Supplemental Budget of Ormoc City for calendar year 1986 with a total appropriation of SEVEN HUNDRED NINETY-FIVE THOUSAND FIVE HUNDRED PESOS (P795,500.00) for purposes therein specified out of funds therefor provided in the aggregate sum of SEVEN HUNDRED NINETY-FIVE THOUSAND FIVE HUNDRED PESOS (P795,500.00) to, as it is hereby, APPROVED.

SECTION 2. Effectivity. - This Appropriation Ordinance shall take effect immediately upon its approval.


