RESOLUTION NO. 23

A RESOLUTION EARNESTLY REQUESTING THE HONORABLE EMETERIO V. LARRAZABAL, OFFICER IN-CHARGE, CITY MAYOR'S OFFICE TO DIRECT THE OFFICER IN-CHARGE, CITY ENGINEER'S OFFICE, TO CAUSE THE ASSIGNMENT OF THE CITY'S DRILLING RIG TO BARANGAY GUINTIGUI-AN FOR DRILLING AND INSTALLING EIGHT (8) LENGHT PIPES 1-1/2 INCH IN DIAMTER FOR A FREE-FLOWING ARTESIAN WELL.

"WHEREAS, the Sangguniang Pambarangay of Guintigui-an in its Resolution No. 2, current series, requesting, among others, the Honorable Emeterio V. Larrazabal, Officer In-Charge, City Mayor's Office to cause the assignment of the City Drilling Rig for drilling and installing of eight (8) lenght pipes 1-1/2inch in diameter for a free-flowing artesian well;

"WHEREAS, it is imperative that this request should be given more attention and top priority to have a potable water supply as this has been their felt need project for quite a long time now;

"NOW, THEREFORE, on motion of Kagawad Redoña, seconded by Kagawad Hermosilla; be it

"RESOLVED, to earnestly request the Honorable Emeterio V. Larrazabal, Officer In-Charge, City Mayor's Office, to direct the Officer In-Charge, City Engineer's Office to cause the assingment of the City's Drilling Rig to Barangay Guintigui-an to drill and install eight (8) lenght pipes 1-1/2 inch in diameter for a free-flowing artesian well;

"RESOLVED, FURTHER, to furnish a copy of this resolution each to the Officer In-Charge, City Engineer's Office, the City Drilling In-Charge, and the Sangguniang Pambarangay of Guintigui-an, all in Ormoc City;
