MOVIES AND LIVE SHOWS AND THE LIKE IN THE CITY OF ORMOC,
TO BE CHAIRMANED BY THE HONORABLE EMMETERIO V. LARRAZABAL,
OFFICER-IN-CHARGE, CITY MAYOR'S OFFICE, SUBJECT, HOWEVER,
TO THE CONDITIONS STIPULATED BY THE NATIONAL BOARD OF
CENSORS, MANILA, OR ANY LAWS THEREOF.

"WHEREAS, the Honorable Avelina Subingsubing brought to the
attention of her colleagues regarding the rampant showing of indes-
cent shows of some of our movie houses, not to mention the video
and live shows and the like in the City of Ormoc;

"WHEREAS, it has been observed that the Local Board of Cen-
sors has been inactive for quite some time now;

"WHEREAS, it is about time to reactivate the Local Board of
Censors considering the fact that there were complaints aired by
some of our constituents that some shows are indecent to the pub-
lic and giving bad example to our youths;

"NOW, THEREFORE, on motion of Kagawad Subingsubing, seconded
by Kagawad Hermosilla; be it

"RESOLVED, to reactivate the Local Board of Censors for movies
live shows, and the like, in the City of Ormoc, to be chairmaned by
Honorable Emeterio V. Larrazabal, Officer-In-Charge, City Mayor's
Office, Subject, However, to the conditions setforth by the Natio-
nal Board of Censors in Manila or any laws thereof.
