RESOLUTION NO. 26

A RESOLUTION EARNESTLY REQUESTING HONORABLE MARIANO R. SANTIAGO, OFFICER-IN-CHARGE, LAND TRANSPORTATION COMMISSION, (LTC), EAST AVENUE, QUEZON CITY TO GIVE ANOTHER EXTENSION FOR THE LEGALIZATION OF TRICYCLES IF POSSIBLE UP TO JULY 30, 1986 SO THAT OPERATORS CAN AVAIL OF THE FEES WITHOUT PENALTY.

"WHEREAS, Honorable Mariano R. Santiago, Officer-In-Charge of the Land Transportation Commission, East Avenue, Quezon City, issued a Memorandum Circular No. 86-006, dated May 7, 1986 regarding the extension for the legalization of tricycles i.e., up to June 6, 1986 only without any further extension;

EREAS, Kagawad Antero T. Fiel in his capacity as Chairman on Transportation of the Sangguniang Panlungsod ng Ormoc manifested that according to the Officer-In-Charge, Land Transportation in Ormoc City the penalty imposed for those who fail to legalize colorum tricycles within the period specified therein is \$2,000.00 plus the miscellaneous fees corresponding thereto operators will have to pay more or less P3,000.00;

"HEREAS, Guideline No. 3 of said Memorandum Circular states among others, that 'Those who fail to avail of this extension within the period specified herein shall not be entitled to the amnesty provided in Section 12(a) of Letter of Instruction No. 1482 dated October 14, 1985 and likewise, their tricycle units shall be impounded and will be released only upon payment of all unpaid fees and penalties due hereto.

"WHEREAS, it is but imperative to ask for another extension for the legalization of tricycles for the benefits of the tricycle operators and for the good of public service, considering this august Body received the Memorandum Circular only today 18th day of June the date for extension has already expired;
