RESOLUTION NO. 26-A

A RESOLUTION AUTHORIZING THE HONORABLE EMETERIO V. LARRAZABAL, OIC, CITY MAYOR'S OFFICE, FOR AND IN BEHALF OF THE CITY OF ORMOC TO ENTER INTO A NEGOTIATED CONTRACT WITH THE T. LIM CONSTRUCTION OF TACLOBAN CITY FOR THE CONSTRUCTION OF ONE UNIT HOME ECONOMICS BUILDING AT SABANG-BAO COMMUNITY SCHOOL, THIS CITY.

"WHEREAS, the City Treasurer in his communication of June 18, 1986 has requested the Sangguniang Panlungsod ng Ormoc to pass a resolution authorizing the Honorable Emeterio V. Larrazabal, Officer In-Charge, City Mayor's Office, to enter into a negotiated contract with the T. Lim Construction of Tacloban City for the construction of one unit Home Economics Building at Sabang-Bao Community School, this city;

"NOW, THEREFORE, on motion of Kagawad Subingsubing, unanimously seconded by all the rest of the Kagawad present, except Kagawad Fiel who dissented; be it

"RESOLVED, to authorize the Honorable Emeterio V. Larrazabal, Officer In-Charge, City Mayor's Office to enter into a negotiated contract with the T. Lim Construction of Tacloban City for the construction of one unit Home Economics Building at Sabang-Bao Community School, this city;

"RESOLVED, FURTHER, to furnish a copy of this resolution each to the T. Lim Construction, Tacloban City; and the City Engineer and the City Treasurer, both of Ormoc City;

"CARRIED. 7 affirmative votes; one dissenting vote registered by Kagawad Fiel";
