RESOLUTION NO. 28

A RESOLUTION CONFIRMING ORDINANCE NO. 49, DATED MARCH 11, 1986 OF THE SECOND SANGGUNIANG PANLUNGSOD NG ORMOC AND AUTHORIZING THE HONORABLE EMETERIO V. LARRAZABAL, OIC, CITY MAYOR'S OFFICE TO APPOINT THE FIRST SET OF OFFICERS OF BARANGAY ALTA VISTA AS PROVIDED FOR IN SECTION 6 OF SAID ORDINANCE.

"WHEREAS, on March 11, 1986 the then Second Sangguniang Panlungsod ng Ormoc passed and approved Ordinance No. 49, entitled "An Ordinance creating Barangay Alta Vista from out of Sitios Tunghan, Catoto-an and Patag Squatters Relocation Site, part of Barangay Patag with the seat of the Government at Sitio Patag Squatters Relocation Site";

"WHEREAS, according to the report submitted by the City Election Registrar on the result of the Plebiscite conducted last May 10, 1986 out of 137 voters 134 voted in favor and only 2 voted against of the separation of said Sitio from its mother barangay of Patag; 1 abstension;

"WHEREAS, Section 5 provides that said Ordinance 49 shall take effect after the lapse of ten days from approval by a majority of votes cast a plebiscite called for the purpose by the Commission on Elections to be held in the unit, or units affected of the new barangay, which shall be held within sixty days from its passage;

"WHEREAS, after lengthy discussion and interpellation the august Body has no other recourse but to confirm Ordinance No. 49, dated March 11, 1986 of the Second Sangguniang Panlungsod ng Ormoc;

"NOW, THEREFORE, on motion of Kagawad Fiel, seconded by Kagawad Subingsubing; be it

"RESOLVED, to confirm Ordinance No. 49, dated March 11, 1986 of the Second Sangguniang Panlungsod ng Ormoc and authorizing the Honorable Emeterio V. Larrazabal, OIC, Office of the City Mayor to appoint the first set of officers of Barangay Alta Vista as provided for in Section 6 of said Ordinance;

"RESOLVED, FURTHER, to furnish a copy of this resolution each to the Sr. Local Government Officer, MLG, the City Election Registrar, COMELEC, and the Sangguniang Pambarangay of Alta Vista, all in Ormoc City;

"CARRIED UNANIMOUSLY".
