RESOLUTION NO. 32

A RESOLUTION AUTHORIZING THE HONORABLE EMETERIO V. LARRAZABAL, OFFICER IN-CHARGE, CITY MAYOR'S OFFICE, IN BEHALF OF THE CITY GOVERNMENT OF ORMOC TO SIGN A DEED OF ABSOLUTE SALE WITH MS. NICOLASA D. ESMERO, COVERING 870 SQUARE METERS OF THE LATTER'S LOT NO. 2346-B-1 SITUATED AT BARANGAY PUNTA TRAVERSED BY THE DON FELIPE LARRAZABAL ROAD AT THE RATE OF P70.00 PER SQUARE METER AS APPRAISED BY THE ASSESSMENT DEPARTMENT BASED ON THE SCHEDULE OF MARKET VALUES OBTAINING IN 1978 WHEN SAID LOT WAS TAKEN BY THE CITY GOVERNMENT FOR ROAD WIDENING.

"WHEREAS, there is now being prepared a deed of absolute sale for signatures by the Honorable Emeterio V. Larrazabal, Officer In-Charge, City Mayor's Office, for and in behalf of the City Government of Ormoc and Ms. Nicolasa D. Esmero covering 870 square meters of her Lot No. 2346-B-1, situated at Barangay Punta traversed by the Don Felipe Larrazabal City Road which was appraised by the Office of the City Assessor at the rate of Seventy Pesos (P70.00) per square meter, based on the schedule of Market Values obtaining in 1978 when said lot was taken by the City Government for road widening;

"NOW, THEREFORE, on motion of Kagawad Sumaljag, seconded by Kagawad Hermosilla; be it

"RESOLVED, to authorize the Honorable Emeterio V. Larrazabal, Officer In-Charge, City Mayor's Office, for and in behalf of the City Government of Ormoc, to sign the deed of absolute sale with Ms. Nicolasa D. Esmero covering 870 square meters of her Lot No. 2346-B-1 situated at Barangay Punta, this city traversed by the Don Felipe Larrazabal City Road at the rate of P70.00 per square meter as appraised by the Assessment Department based on the Schedule of Market Values obtaining in 1978 when said lot was taken by the City Government for road widening;

"RESOLVED, FURTHER, to furnish a copy of this resolution each to the City Engineer, the City Treasurer, the City Assessor, the City Budget Officer, and Ms. Nicolasa D. Esmero, all in Ormoc City;
